

## 1. Features and Technical Parameters

#### 1.1 Features

- DIN RAIL standard installation size.
- Only 18mm wide, can handle up to 100A.
- Meter has backup 3.6V Lithium battery.
- Blue LCD backlight allows the meter to be read in low light conditions.
- Displays Current and Voltage.
- Reactive energy can be measured.
- Material of Meter housing: ABS fire resistant.
- Degree of Protection: IP51 (Indoor meter).




## 2. Description






#### 3.1 Dimensions of LCD Screen
